Bids were opened for the above referenced project on Wednesday March 14, 2012 at 2:00 p.m. The project consists of drilling a new irrigation water well for GISD, including all drilling, casing, screen, testing and developing at Gadsden Elementary School in Anthony, NM.

The project was bid on a unit price cost basis. Final quantities may vary from those estimated in the Bid Schedule. One bid was received before the scheduled Bid Opening. A tabulation of the bids and the engineer's estimate of probable cost are attached. A summary of the bid is shown below:

The contract documents require that bidders hold the bid prices for a period of sixty (60) days after the bid opening to allow the Owner to evaluate the bid proposals.

It is our understanding that GISD currently has funding for the total base bid of the project. On the basis of the above, I recommend that GISD award the project to HydroGeologic Services Inc. in the amount of \$74,920.00.

The Gadsden Independent School District is required to take action (in the form of a vote) to accept or revise this recommendation in accordance with the GISD's objectives for award of the construction contract.
