

REGULAR SCHOOL BOARD MINUTES

For February 26, 2015

1. The Gadsden School Board convened in regular session at 5:08 p.m. Vice-President Viramontes presided at the meeting held at the Gadsden Administrative Complex Board Room.

They created their own travel agency website featuring four destinations. The team will now travel in May to Anaheim for national competition.

Associate Superintendent Susan Yturralde announced that the District Spanish Spelling Bee competition had taken place on Wednesday, February 25th. Amparo Arredondo took 3rd place, Rene Melendez took 2nd place and Maria del Sol Nuñez-Peña a 5th grade student from Chaparral Elementary placed 1st. Maria del Sol also placed 2nd in the English Spelling Bee. She announced the 18 students from 15 of our elementary schools and our 3 middle schools would be competing on Friday, February 27, 2015 at Bel Air High School.

Quarterly Budget Report for the Month Ended December 31, 2014 A. Steve Suggs, CFO presented information on the Quarterly Budget Report for the Month ended December 31, 2014. He said that the cash balance was still on target and that the reimbursement process continues to move forward. The District has \$1.5 milion invested in CD's.

April 9, 2015 Regular **Board Meeting** B. Superintendent Yturralde informed the Board that most of the administrative staff would be attending the Spring Budget Workshop April 8th -10^{th} , and that there was a possibility that the April 9th regular board meeting would need to be canceled or postponed. Mr. Suggs said the District had not yet received word on the carryovers and that would determine if we needed to reschedule the meeting for April 16th or if the meeting could be canceled.

Adjourn 10. Ms. Saenz made a motion to adjourn the meeting. Superintendent Yturralde recommended approval of the motion. Motion carried. The meeting adjourned at 6:00 p.m.
