

Monthly Budget Report For The Month Ended January 31, 2015 A. Steve Suggs, CFO, presented information on the monthly budget report for the month ending January 31, 2015.

Language Arts & Modern/Classical Languages 9-12 Textbook Adoption B. Manuel Leyva, Instructional Resources Specialist, presented information on the proposed recommendations for Language Arts and Modern Classical Languages textbook adoption for the secondary schools. Mr. Leyva said that teachers from each campus served on the committee that reviewed and evaluated materials sent in by the publishers.

MOU with FYI-Juvenile Assessment & Reporting Center C. Julie Molina, Juvenile Assessment and Report Center (JARCC) Supervisor and FYI Director Annabel Fierro presented information regarding the proposed JARCC mobile unit that they would like to take to Gadsden Middle School, Gadsden High School and Desert Pride Academy. Board Member Ford asked for more clarification on the Memorandum of Understanding. He asked for clarification on the students that they serve and to whom the information is reported to. Ms. Molina and Ms. Fierro

explained that they work in conjunction with the Juvenile Probation Office. Ms. Molina explained that their funding comes from CYFD - Children, Youth and Families Division. Board President Saenz asked if they worked with Las Cruces Public Schools and if the items on Memorandum of Understanding were ironed out would they consider expanding and including the Sunland Park and Chaparral areas. Ms. Molina added that they currently work with Las Cruces Public Schools and would consider adding the before mentioned areas contingent upon funding. Secretary Viramontes asked if this was a current service being provided or a new service and if student truancy is being addressed in this program. She also asked if students would be pulled out of classes, because sometimes the same students are pulled out by several agencies. Both Ms. Molina and Ms. Fierro said they have been working with Carolyn Lindau and would continue to work with her to iron out all of the concerns expressed by the Board. Superintendent Yturralde said that any agency that can come and help with at risk students is welcome.

- D. Physical Plant Director Alfredo Holguin and Associate Superintendent Barbara Browder presented information on the proposed Internship Agreement with Western Technical. The interns will have the opportunity to learn hands on, assisting them with the transition from school to work.
