January 19, 2018	Suggested date for publication of first of two publications of election proclamation with question and poll workers. (NMSA 1978, § 1-22-11).
January 26, 2018	Suggested date for publication of second of two publications of proclamation with question and poll workers. (NMSA 1978, § 1-22-11).
February 2, 2018	Friday before February 6, 2018 special election and last date to vote Absentee. (NMSA 1978, §§ 1-6-1 through 1-6-23, and § 1-22-19).
February 6, 2018	Election Day.
February 7, 2018	First day to canvass election. (NMSA 1978, § 1-22-15C).
February 9, 2018	Last day to canvass election. (NMSA 1978, § 1-22-15C).

Suggested date for publication of results of election. (NMSA 1978, § 1-22-15E and § 22-18-10).

March 1, 2018
