**April 30, 2019**  
**Monthly Budget Report**

1. Operational Fund Revenues as of April 30, 2019 - \$87,667,249 which represents 84.10% of budgeted Revenues.

2. Operational Fund Expenditures as of April 30, 2019 - \$76,610,527 which represents 63.31% of budgeted Expenditures.

3. The April 30, 2019 Operational Fund Cash Balance before loans was \$41,836,036. The cash balance after temporary loans of \$3,870,847 to the grant funds was \$37,965,189. Grant funds that reported a negative cash balance as of April 30, 2019 totaled \$3,870,847, which represents an increase of \$1,208,801 from the March 31, 2019 negative balances.
4. As of April 30, 2019, the PED and other grant funding agencies owed the District approximately \$4,095,068 for current year Grant Fund expenditures, \$697,015 for Capital Projects, and \$1,706,735 for Student Nutrition. These amounts are not reflected in the temporary loans noted in Item 3 above. The negative cash balances noted in Item 3 are a result of the outstanding amounts owed to the District.
5. Total Revenues for all funds as of April 30, 2019- \$139,993,573. Of the total revenues received, the Operational Fund accounted for 62.62%, the Grant Funds 10.89%, Building Funds 10.47%, Debt Service Funds 7.00%, Student Nutrition 4.41%, and all the other funds 4.61%.
6. Total Expenditures for all funds as of April 30, 2019- \$124,941,590. Of the total expenditures incurred, the Operational Fund accounted for 61.32%, the Grant Funds 10.47%, Building Funds 8.45%, Debt Service 9.368%, Student Nutrition 5.89%, and all other funds 4.52%.
7. Direct Instruction expenditures plus encumbrances for the Operational Fund as of April 30, 2019 were \$63,334,758 or 62.52% of the total Operational Fund expenditures.
8. Pledged collateral – All bank accounts in compliance at April 30, 2019. See separate report attached Item III Summary of Investments.

9. All schools have been subject to an Internal Review during 2018-2019. Below is a summary of the results.

1. Operational Fund Revenues as of March 31, 2019 - \$78,800,459 which represents 75.59% of budgeted Revenues.
2. Operational Fund Expenditures as of March 31, 2019 - \$68,338,719 which represents 56.48% of budgeted Expenditures.
3. Total Revenues for all funds as of March 31, 2019- \$128,717,974. Of the total revenues received, the Operational Fund accounted for 61.22%, the Grant Funds 11.43%, Building Funds 11.33%, Debt Service Funds 7.33%, Student Nutrition 4.14%, and all the other funds 4.55%.
4. Total Expenditures for all funds as of March 31, 2019- \$112,623,120. Of the total expenditures incurred, the Operational Fund accounted for 60.68%, the Grant Funds 10.32%, Building Funds 8.34%, Debt Service 10.38%, Student Nutrition 5.86%, and all other funds 4.42%.
5. Direct Instruction expenditures plus encumbrances for the Operational Fund as of March 31, 2019 were \$62,953,372 or 62.78% of the total Operational Fund expenditures.

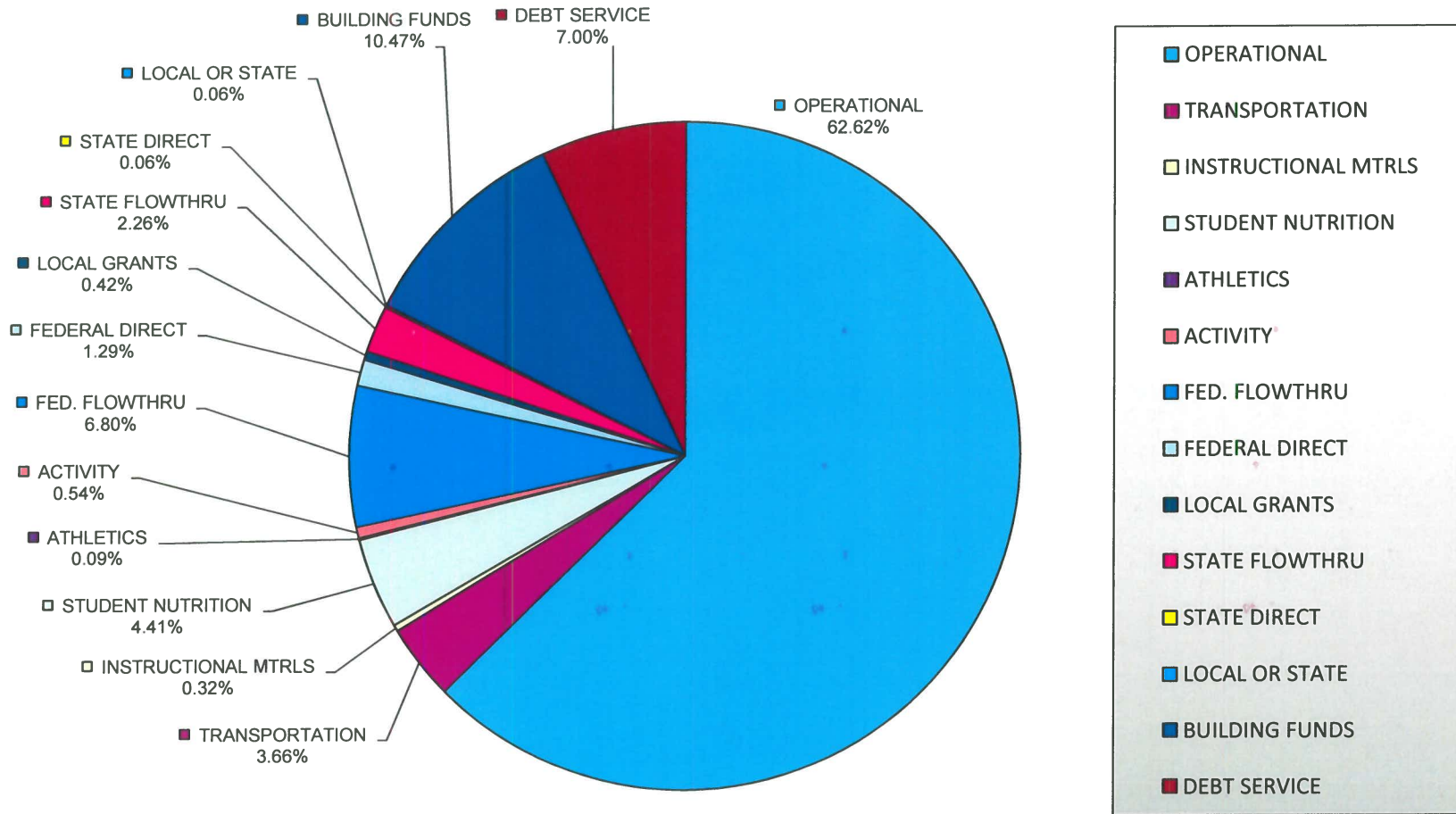

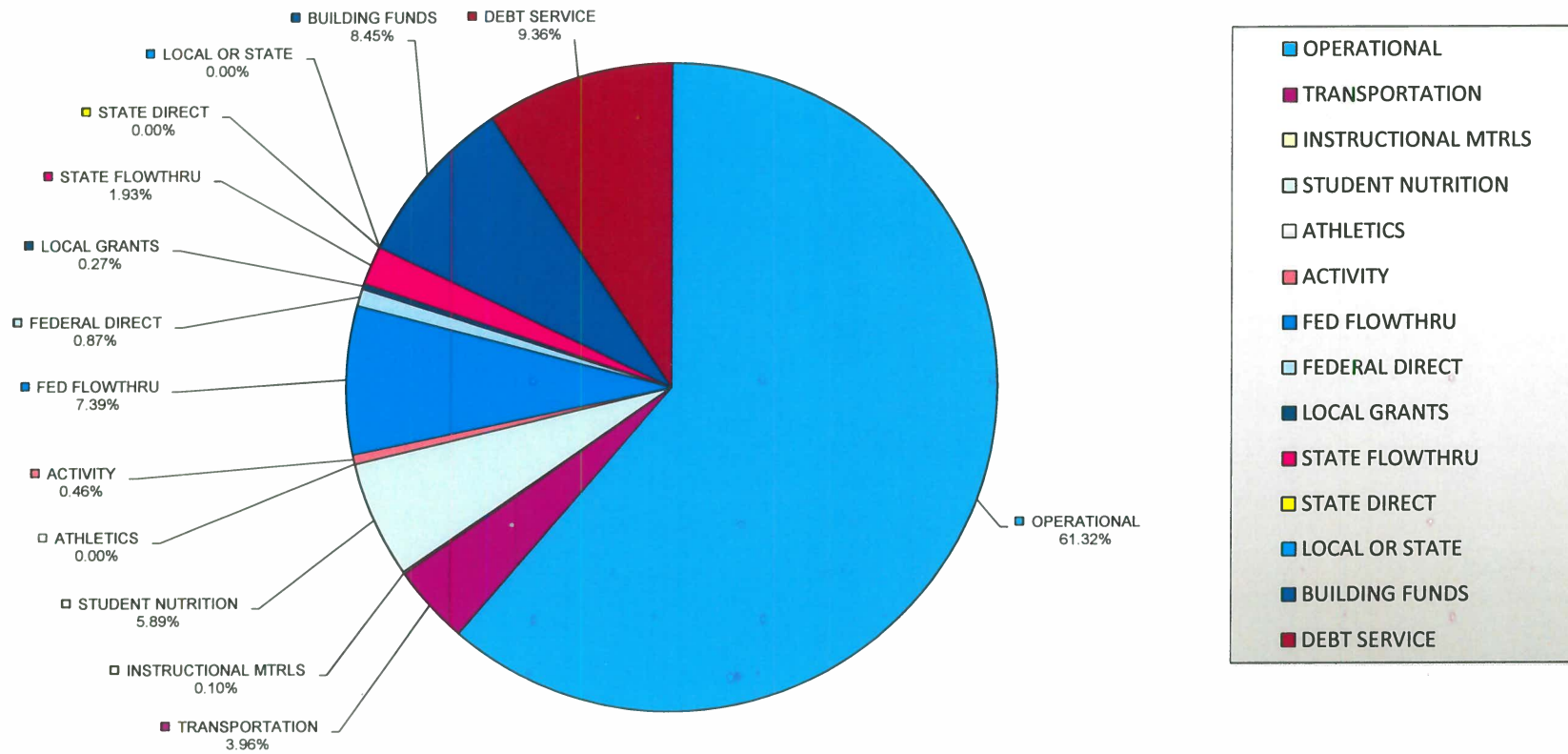

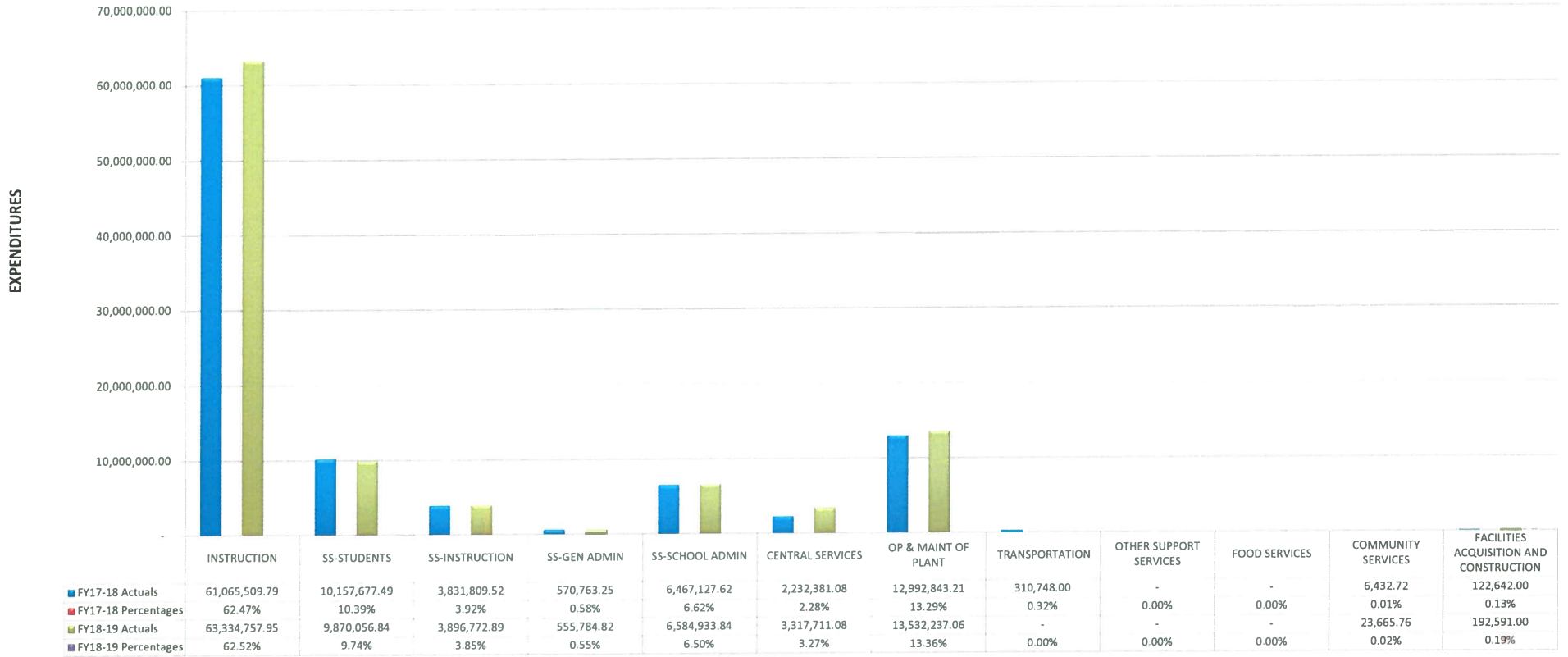
# GISD 2018-19 REVENUES BY FUND APRIL 2019



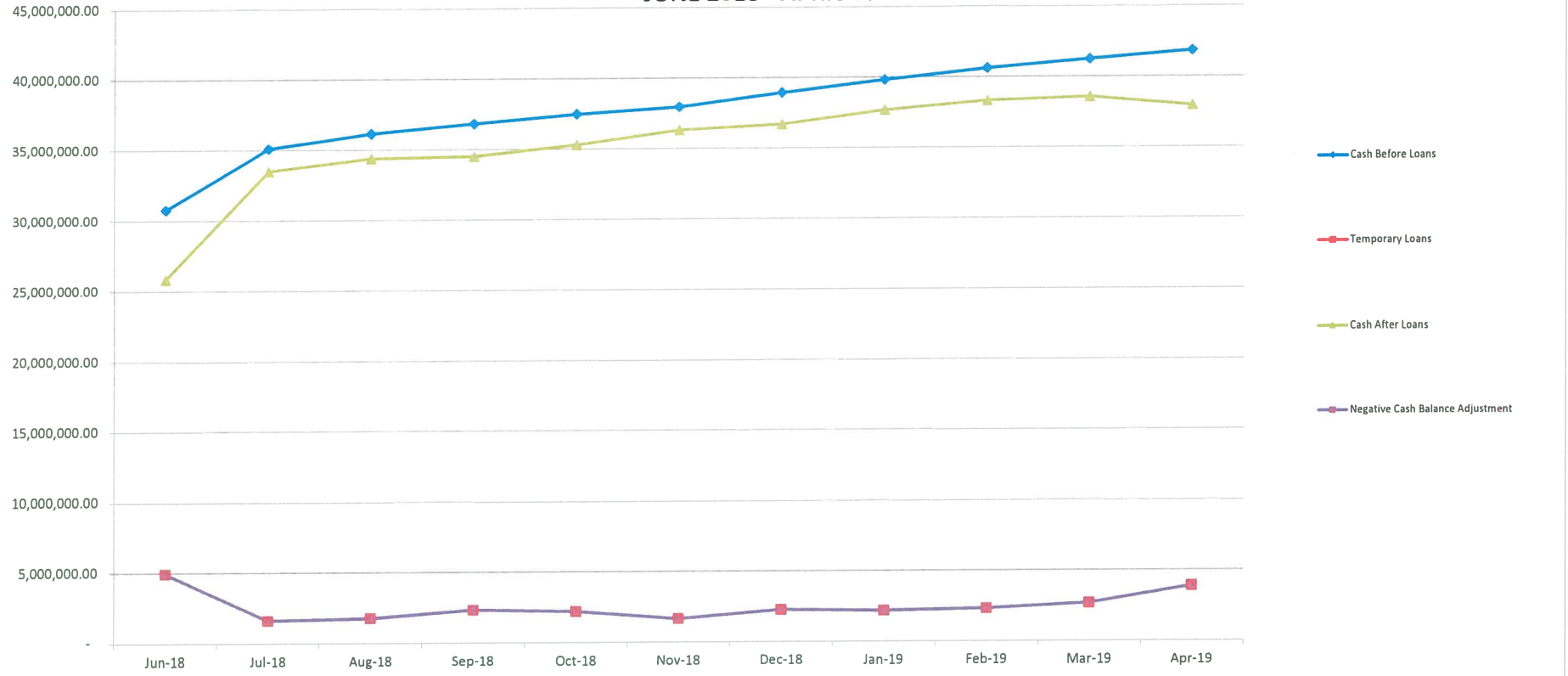
## GISD 2018-19 EXPENDITURES BY FUND APRIL 2019

COMPARED TO APRIL 2019**

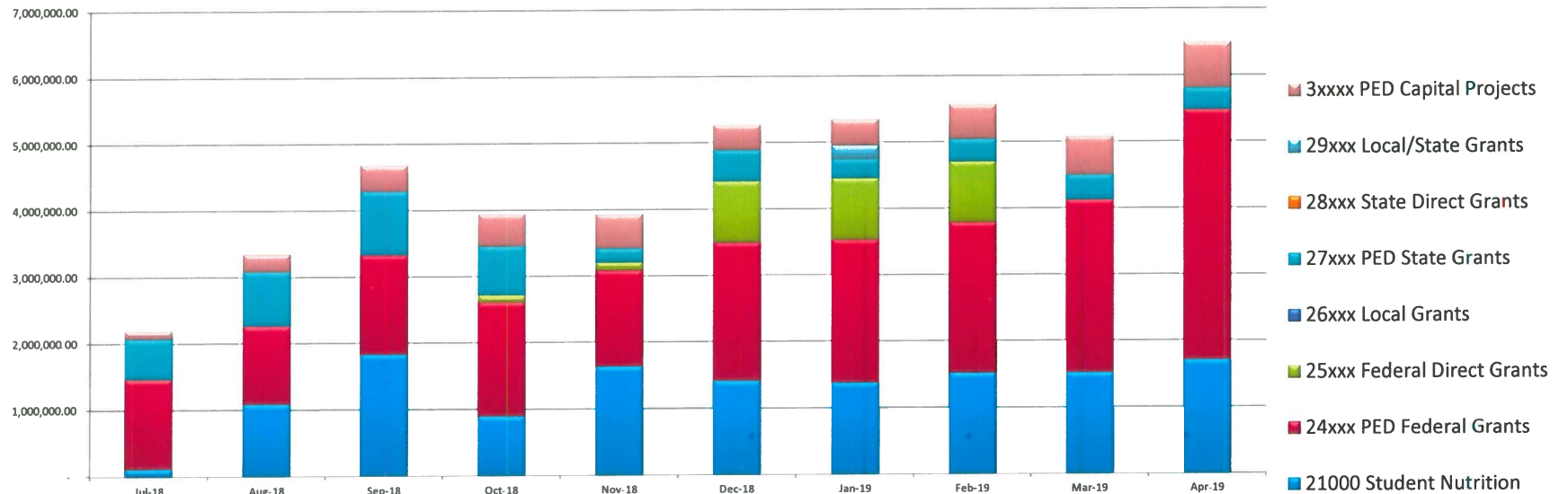


**GISD 2018-19 Cash Balance / Temporary Loan Balance Trend**
