New Mexico State Appropriation-Mental Wellness Rooms (27591)

During the 2023 legislative session, the state appropriated funding for Mental Wellness Rooms. The New Mexico Public Education Department (PED) has determined its final FY 23-24 award for the Wellness Room Grant which is illustrated on Exhibit C. This funding is to be used specifically for public school districts to provide wellness rooms as a place to cultivate social emotional learning (SEL), with an emphasis on self-regulation; and a prevention and/or intervention strategy within a Multi-Layered System of Supports (MLSS). This award is based upon reimbursable expenditures. Adherence to the requirements as detailed in the supplement and documentation supporting expenditures is required.


