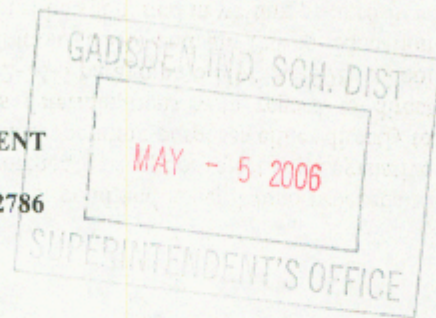

Dear Dr. Mora :

During the 2006 legislative session, the Legislature appropriated severance tax bond and general fund proceeds to your district for capital outlay projects. A school district must determine whether to accept or reject any Legislative appropriation made directly to the school district after January 1, 2003 for non-operating purposes either directly to the school district or to another governmental agency. This includes determinations with regard to direct appropriations for charter schools within the school district. Pursuant to 22-24-5 paragraph 6 NMSA 1978, school districts are required to notify the Department of Finance and Administration (DFA) and the Public Education Department (PED) if it is rejecting an appropriation. The rejection notice must be submitted in writing prior to June 1st of the fiscal year when the appropriation was made. If the DFA and PED are not notified in writing prior to this date the appropriations will be deemed as accepted. If a school district does not reject the direct appropriation, an offset will apply to future Public School Capital Outlay Council awards for all projects in the school district, not just the school for which the direct appropriation is made. The rejection of the direct appropriation must be supported by the action of the local school board.
