The purpose of CASH project is to establish a behavioral modification energy conservation program throughout the State of New Mexico Public School Districts. The program objectives are as follow:

- 1. Create school district CASH Policy, establish goal's for the program and establish supporting school district objectives.
- 2. Designate a Champion position, responsible individuals, means of implementing the program, and a CASH Team.
- 3. Establish a process (checklist) for Administrators, Teachers and Trainers for implementing CASH program, along with continuation of program.
- 4. Implement a behavioral modification energy conservation education program with materials for use by instructional personnel in the day to day program to the students.
- 5. Establish energy conservation awareness training for all school personnel.
- 6. Establish an evaluation program and means of celebrating success.
- 7. Create video showing the CASH project objectives as a teaching tool for other schools to incorporate CASH program. Providing actual hands on demonstrations. The video shall have segments from each school district.
