Dear Board Members:

On Tuesday April 3, 2007, a bid was received for the above referenced project as shown on the enclosed Bid Tabulation sheet. Five firms had the bid documents and only one bid was received. We contacted three firms to better understand their lack of response and were told the complexity of the work involving several subcontractors, and the volume of roofing work available determined their lack of interest.

The work included in the Base Bid and Alternate #1 is at Santa Teresa High School. This work is funded by the Public School Facilities Authority (PSFA) and the bid slightly exceeds the money available. Alternate #1 work can be delayed since the gymnasium roof is in good general condition but requires some minor repairs. The Base Bid work is for the low roof surrounding the gymnasium and this deteriorated roof requires immediate attention. The Base Bid is within the PSFA funds available.

The work included in Alternate #2 is re-roofing the entire Gadsden Administration Center, a roof with numerous leaks, poor drainage, and serious deterioration. This work requires immediate attention and is within the funds available.

It is highly questionable whether re-bidding the roofing would find more interest and bids or whether the cost would be lower. We have had Dynacon on previous work and recommend acceptance of their Base Bid and Alternate #2 and awarding them a contract for \$686,133.00. Attached is a copy of our estimate.
