Dear Ms. Nava:

On January 16, 2008, President Bush signed the FY 2008 Omnibus Appropriation Act, which provides additional funding to expand the Fresh Fruit and Vegetable Program (FFVP).

The recent federal legislation authorizes funds from March 2008 to September 30, 2009 for the Fresh Fruit and Vegetable Program. The grant period will end September 30, 2009. Program funds must be expended by participating schools by September 30, 2009.

In order to budget these funds, please submit an electronic Budget Adjustment Request (BAR) utilizing the PED OBMS (Operating Budget Management System) website. The Flowthrough BAR process is located on the PED website at www.ped.state.nm.us. I also encourage you to work with your school district finance person that has been notified of this new process for submission.

Please submit electronic Budget Adjustment Request (BAR) in the amount of \$ 30,552.00 utilizing **Fund Code ~~21000~~ and Revenue Code: 43500.**

The program is an important catalyst for change in efforts to combat childhood obesity by helping children learn more healthful eating habits. The FFVP introduces school children to a variety of produce that they otherwise may not have the opportunity to sample. The program is used primarily to purchase unique fresh fruits and vegetables, and must be made available at no charge to all students.

Use of Funds

Funds are to be used primarily to purchase fresh fruits and vegetables and to be available at no charge to students three days out of the school week. A school may use up to 10% of the funds for administrative costs. Please note that labor costs associated with preparing and distributing the fruits and vegetables are not considered administrative costs and should be shown as general operating costs, which must be reasonable and necessary.

The program should be structured so that the maximum benefits go to children. Information is provided in the Fresh Fruit and Vegetables Program Handbook, Appendix A and on the FFVP Partner website at <https://www.fnspartner.usda.gov/>.

Expectations of Participating Schools

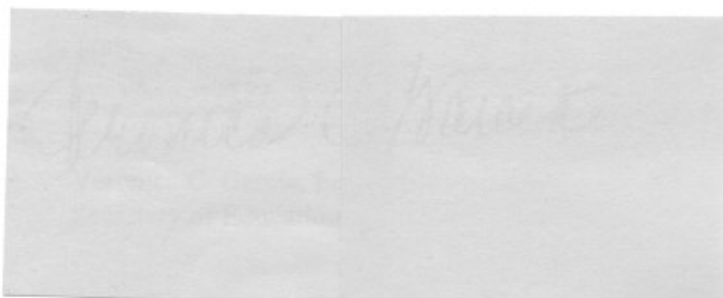
Participating schools are required to publicize the availability of free fresh fruits and vegetables to the student body at least three days out of the week. Schools must make free fruits and fresh vegetables available to students throughout the school day in one or more areas designated by the school. Schools must provide nutrition education related to benefits of having fresh fruits and vegetables as snacks.
