Dear Ms. Nava:

In accordance with 2010 legislative language under House Bill 2, Gadsden Independent Schools has been awarded \$137,126.50 for the purpose of Breakfast for Elementary Students.

Funding under this award must be used as specified by legislation and allowable under the application submitted and approved through the Student Nutrition Bureau. These funds are to be fully expended by June 30, 2011.

Funds will be allocated in two (2) approximately equal payments. The first allocation will be distributed in August 2010 and the final in January 2011. The amount of the final payment is contingent upon changes to the original appropriation which may be enacted through future legislation.

In order to budget these funds, please submit an electronic Budget Adjustment Request (BAR) utilizing the PED OBMS (Operating Budget Management System) website. The Flowthrough BAR Process is located on the PED website at [www.ped.state.nm.us](http://www.ped.state.nm.us). I also encourage you to work with your school district finance person that has been notified of this new process for submission.

Please submit an electronic Budget Adjustment Request (BAR) in the amount of \$137,126.50 utilizing Fund Code 27155 and Revenue Code 43202.
