- **September 30, 2013** – Last day to expend funds for the Basic Grant redistribution grant activities authorized within this application
- **October 25, 2013** – Last day to request a final reimbursement for FY14 Basic Grant redistribution grant activities
- **December 1, 2013** – Award **CLOSED**
