1. The Gadsden School Board convened in regular session at 5:00 p.m. President Saenz presided at the meeting held at the Gadsden Administrative Complex. Introduction and Members present: Maria Saenz, Daniel Estupiñan, Craig Ford, and Roll Call Jennifer Viramontes. Member absent: Daniel Castillo. Pledge & 2. The Pledge of Allegiance and the Pledge to the New Mexico flag were Mission Statement recited. The mission statement was read by Secretary Viramontes. 3. Programs, Reports, and Correspondence: A.
