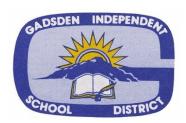

9. Discussion Items:

- A. Erica Villareal, Budget and Compliance Director presented information on the Quarterly Budget Report for the Month Ended March 31, 2015.
- B. Karen Nougues, Athletic Director, presented information on the amendment to Policy JJIB, Interscholastic Sports. The amendment is due to Senate Bill 137 passing during the 2016 legislative session. Bill 137 increases the time that a student athlete is to be prohibited from practice because of a concussion, from one week to 240 hours from the hour of the injury. Policy KF also requires persons using any school property for nonscholastic youth activities to follow the same brain injury protocols, and Exhibit KF-EC is a new Nonscholastic Sport Users Certification form that must be completed as a condition of permitting nonscholastic youth athletic activities to take place on school district property. Ms. Nougues said that the only outside entity that uses our campus for nonscholastic you activities is the YMCA.
- C. Alfredo Holguin presented information on the proposed Transportation Contract for 2016 - 2017 school year. The contract with Boone Transportation reflects \$4,263,972 for the "to and from" school bus service and \$562,580 for rents and leases related to the purchase of buses. Total contract with Boone Transportation for the 2016-17 fiscal year would be \$4,826,552. The 2016-17 contract reflects an increase of \$119,577 for the "to and from" school bus services. The rents and leases portion of the contract reflects a decrease of \$20,810 due to changes to the current buses approved for this reimbursement from the State. Mrs. Cristi Stuart, CEO for Boone Transportation was available to answer questions from the Board.

10. Closed Session:

Mrs. Viramontes made the motion to go into Closed Session pursuant to 10-15-1, H-2, NMSA 1978 for Superintendent's and Associate Superintendent's report on recent personnel actions and issues such as: employees on administrative leave with pay, employee grievances, employee issues, pending legal matters. Superintendent Yturralde recommended approval of the motion. Motion carried unanimously. The Board went into Closed Session at 6:00 p.m.

- 11. Mr. Ford made a motion to reconvene in open session. No action was taken. Superintendent Yturralde recommended approval of the motion. Motion carried. The Board reconvened in Open Session at 6:34 p.m.
- 12. Mr. Estupiñan made a motion to adjourn the meeting. Superintendent Yturralde recommended approval of the motion. Motion carried. The meeting adjourned at 6:35 p.m.
