

REGULAR SCHOOL BOARD MINUTES

For November 9, 2021

1. The Gadsden School Board convened in regular session at 5:01 p.m. President Salazar Flores presided at the meeting held at the Gadsden Administrative Complex.

Introduction And Roll Call

Pledge & Mission Statement

- 2. The Pledge of Allegiance and the Pledge to the New Mexico flag was recited. Jennifer Viramontes read the mission statement.
- 3. Superintendent District updates and recognitions:
 - A. Carlos Sanchez, New York Life, presented a grant to Gadsden ISD with a check for \$12,000 on behalf of New York Life Foundation GSSI.
 - B. Superintendent Dempsey presented information on the GO Bond Election Results. He announced that the General Obligation Bond passed and he thanked all our parents, staff, and community partners for their support which allows Gadsden ISD to continue to make improvements to our facilities which supports student achievement.

- C. Superintendent Dempsey presented information on the NM Social Studies Standards: NMPED Hearing November 12, 2021. He stated that NMPED will host a hearing that establishes the standards that all children in New Mexico are suppose to be proficient.
- D. Superintendent Dempsey presented information on the COVID Vaccinations. He stated that GISD will support NMDOH's efforts to provide vaccinations for 5 years of age and up. The first clinic will be held Saturday, November 13th at the Anthony Department of Health. The students must be accompanied by parents. The goal is to provide transportation option for any parent who request additional support.
- E. Student Representative-Ethan Garcia, a sophomore from Alta Vista Early College High School, reported that Alta Vista had a

very festive start to fall. They celebrated spirit week that concluded with the Fall Festival, which included fun games and prizes at the end of the school day. He stated they hosted a Fall Formal, which took place outdoors under the stars. It was great to see students socializing in a different environment. As for Halloween, he stated that they had a costume contest and pumpkin carving competition during lunch. They had lots of participation for these events and students were able to showcase their creativity. The Chess Club meets every Tuesday after school with Mr. Almeida. On October 23rd, Christopher Hernandez, a freshman, participated in the Wiggs Middle School Fall Regional Scholastic Tournament in El Paso, Texas. This was his first chess tournament and he won 1 out of 4 games. The next chess tournament will be on Saturday. November 20th at Park Hills Christian Church. On November 5th, Ms. De La Garza presented in the UNM Diversity Summit virtually alongside with two other early college high schools. The emphasis of the summit was how we serve underrepresented groups of students from three areas, Gadsden ISD, Gallup, and Santa Fe areas. We showcased what we are doing to promote a head start for students in college and how these students are meaningfully supported in the successful acquisition of dual credit. On October 10th, the Science Club took a field trip to Space Port and Dripping Springs National Park. Students were able to take a tour and see the Virgin Galactic and saw a sneak peek of Richard Branson's Spaceship Two. Our students were also selected by the SRCL Grant coordinator, Martha Chacon, to present a video to the New Mexico Department of Education of a lesson utilizing the SRCL Grant resources. This video shows Mrs. Brinegar's English 3 class and how they work collaboratively using discussions to analyze various types of literature and the video also specifically discusses a book called "American Like Me" by America Ferrera. He reported that a classmate Bianca Navarrete, a sophomore, was giving an impromptu narration during the video. She gave an excellent perspective on the book and how it empowers us to accept our differences and embrace our culture. He thanked Mr. Carmona for helping them create such an amazing video.

F. Mr. Cano reported that he attended the National Lunch Competition that Maria Guerra, Director for Student Nutrition Program, hosted at Gadsden High School and it was awesome. He gave a Get-Well card to fellow board member Claudia Rodriguez that couldn't attend the board meeting. He stated he visited her in the hospital and is doing better.

Mr. Castillo also gave a Get Well to Mrs. Rodriguez. He thanked Ethan Garcia for his report on Alta Vista Early College High School. He wished Ethan luck in continuing his journey.

Mrs. Viramontes also thanked Ethan for representing his school. She also thanked New York Life for their contribution to Gadsden ISD. She wished everyone a Happy Veteran's Day.
