February 28, 2023
Monthly Budget Report**

1. Operational Fund Revenues as of February 28, 2023 - \$96,922,411 which represents 66.87% of budgeted Revenues.

2. Operational Fund Expenditures as of February 28, 2023 - \$86,516,897 which represents 42.68% of budgeted Expenditures.

3. The February 28, 2023 Operational Fund Cash Balance before loans was \$77,826,100. The cash balance after temporary loans of \$13,233,517 to the grant funds was \$ 64,592,583. Grant funds that reported a negative cash balance as of February 28, 2023 totaled \$13,233,517 which represents a decrease of \$2,075,422.23 from the January 31, 2023 negative balances.
4. As of February 28, 2023, the PED and other grant funding agencies owed the District approximately \$15,047,189 for current year Grant Fund expenditures, \$0 for Capital Projects, and \$2,216,180 for Student Nutrition. These amounts are not reflected in the temporary loans noted in Item 3 above. The negative cash balances noted in Item 3 are a result of the outstanding amounts owed to the District. (See Exhibit A Outstanding Reimbursements)
5. Total Revenues for all funds as of February 28, 2023- \$169,108,497. Of the total revenues received, the Operational Fund accounted for 57.31%, the Grant Funds 14.95%, Building Funds 13.73%, Debt Service Funds 6.48%, Student Nutrition 4.47%, and all the other funds 3.06%.
6. Total Expenditures for all funds as of February 28, 2023- \$144,695,630. Of the total expenditures incurred, the Operational Fund accounted for 59.79%, the Grant Funds 18.70%, Building Funds 3.86%, Debt Service 9.64%, Student Nutrition 4.70%, and all other funds 3.31%.
7. Direct Instruction expenditures plus encumbrances for the Operational Fund as of February 28, 2023 were \$88,693,548 or 63.39% of the total Operational Fund expenditures.
8. Pledged collateral – All bank accounts in compliance requirement at February 28, 2023. See separate report attached Item III Summary of Investments.

9. In the month of February 2023 schools were not sampled due to time constraints.

Selected items from January 31, 2023 Report:

1. Operational Fund Revenues as of January 31, 2023 - \$84,628,351 which represents 58.81% of budgeted Revenues.
2. Operational Fund Expenditures as of January 31, 2023 - \$72,707,143 which represents 37.84% of budgeted Expenditures.
3. Total Revenues for all funds as of January 31, 2023- \$147,337,258. Of the total revenues received, the Operational Fund accounted for 57.44%, the Grant Funds 12.31%, Building Funds 15.63%, Debt Service Funds 6.96%, Student Nutrition 4.57%, and all the other funds 3.09%.
4. Total Expenditures for all funds as of January 31, 2023- \$123,316,550. Of the total expenditures incurred, the Operational Fund accounted for 58.96%, the Grant Funds 18.03%, Building Funds 4.02%, Debt Service 11.05%, Student Nutrition 4.64%, and all other funds 3.30%.
5. Direct Instruction expenditures plus encumbrances for the Operational Fund as of January 31, 2023 were \$88,178,250 or 63.97% of the total Operational Fund expenditures.

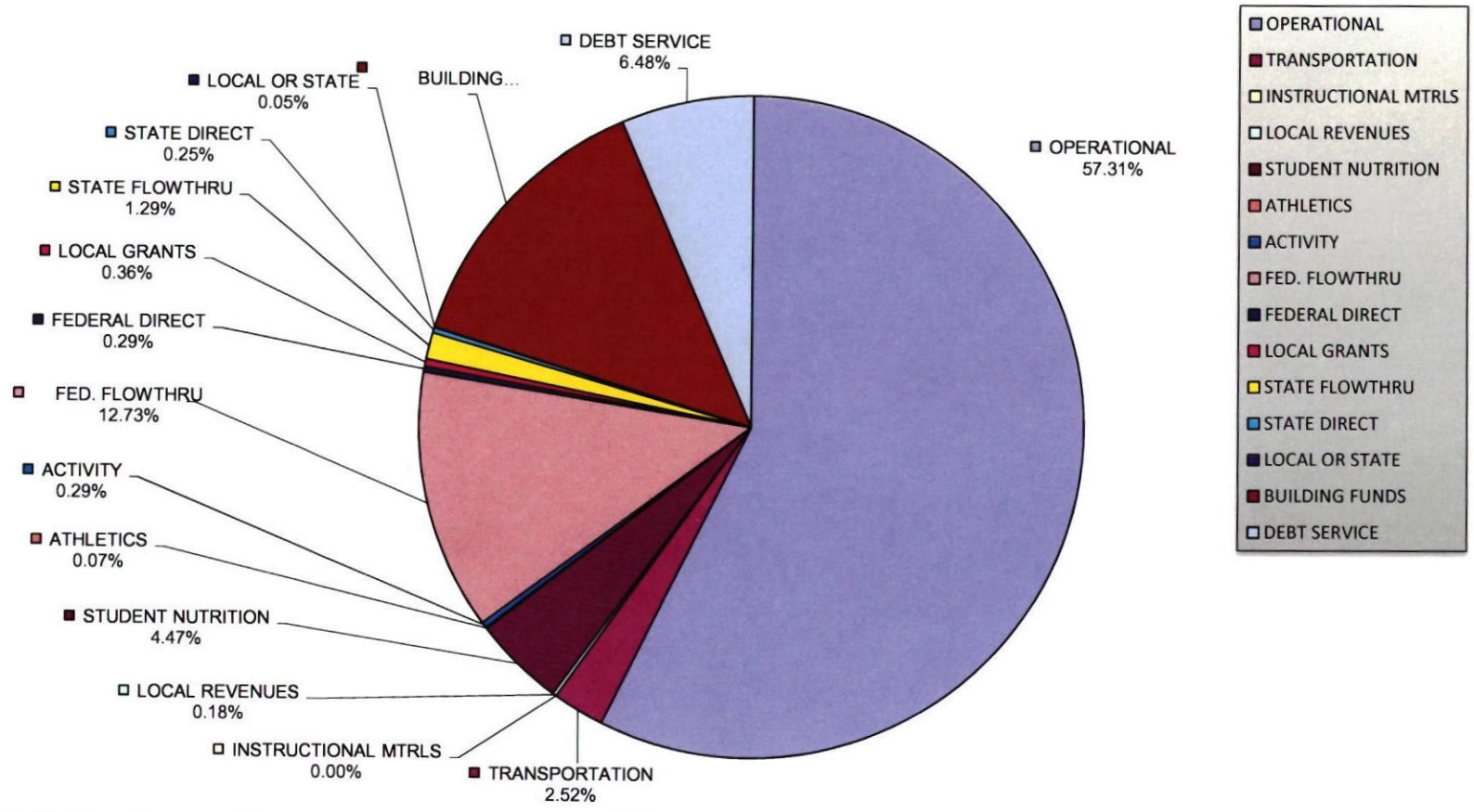

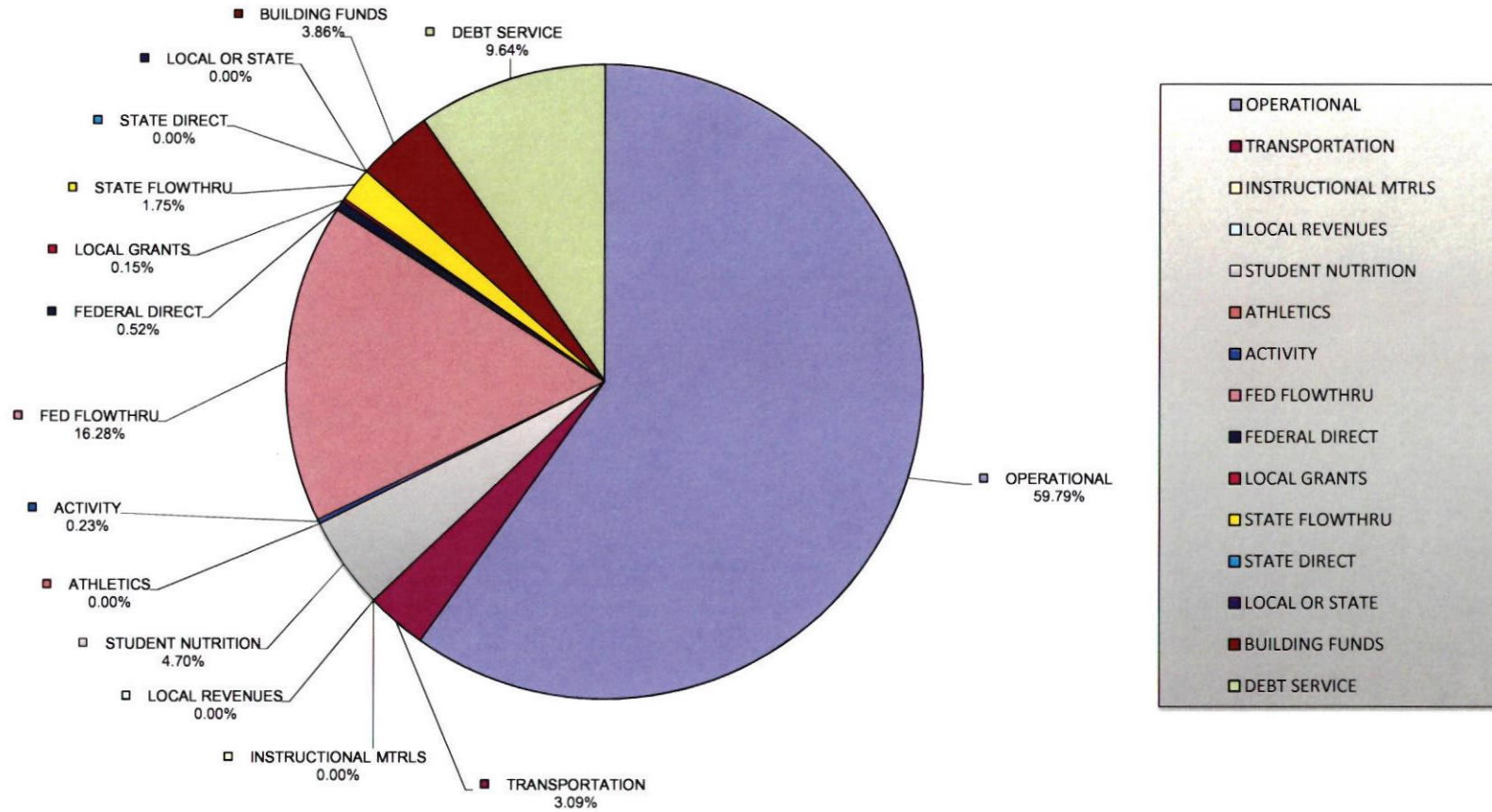

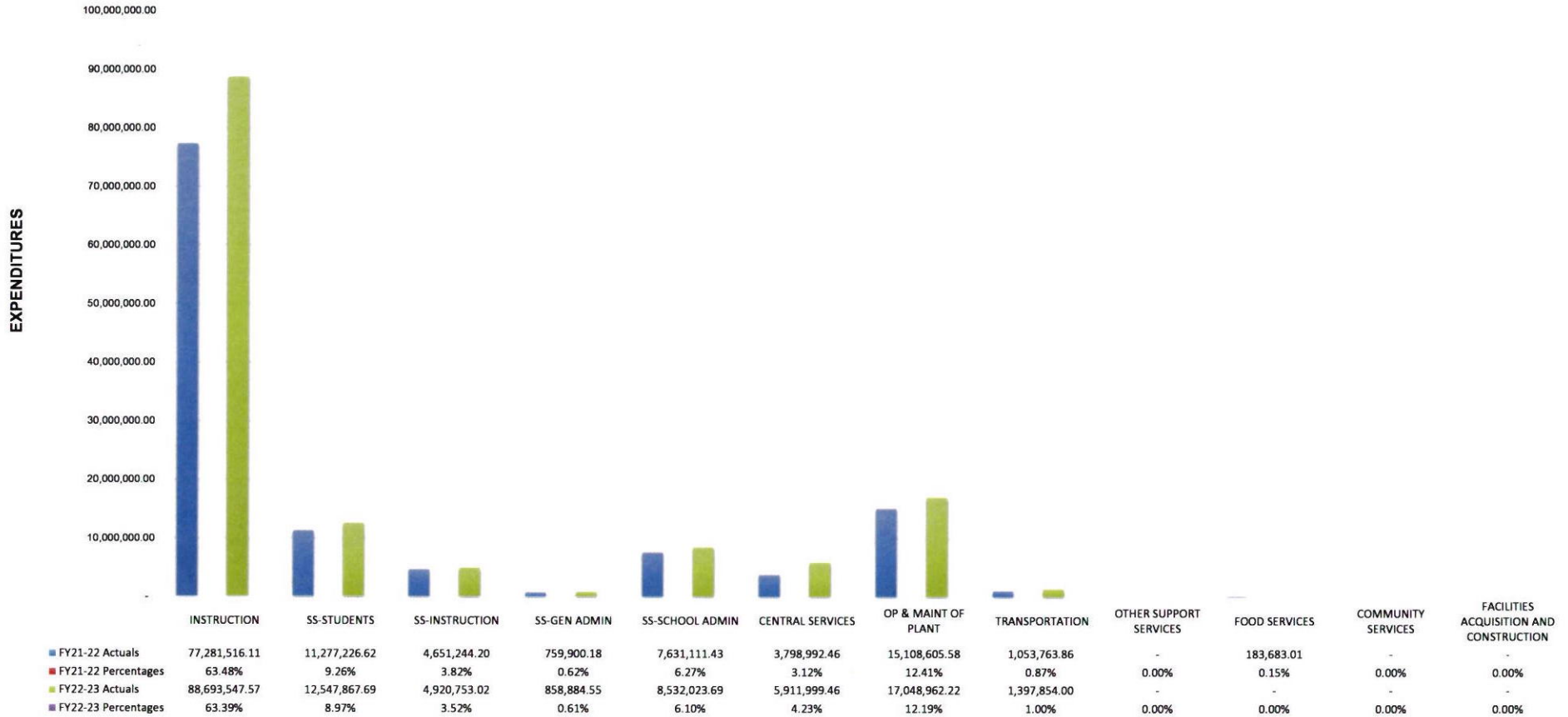
GISD 2022-23 REVENUES BY FUND FEBRUARY 2023



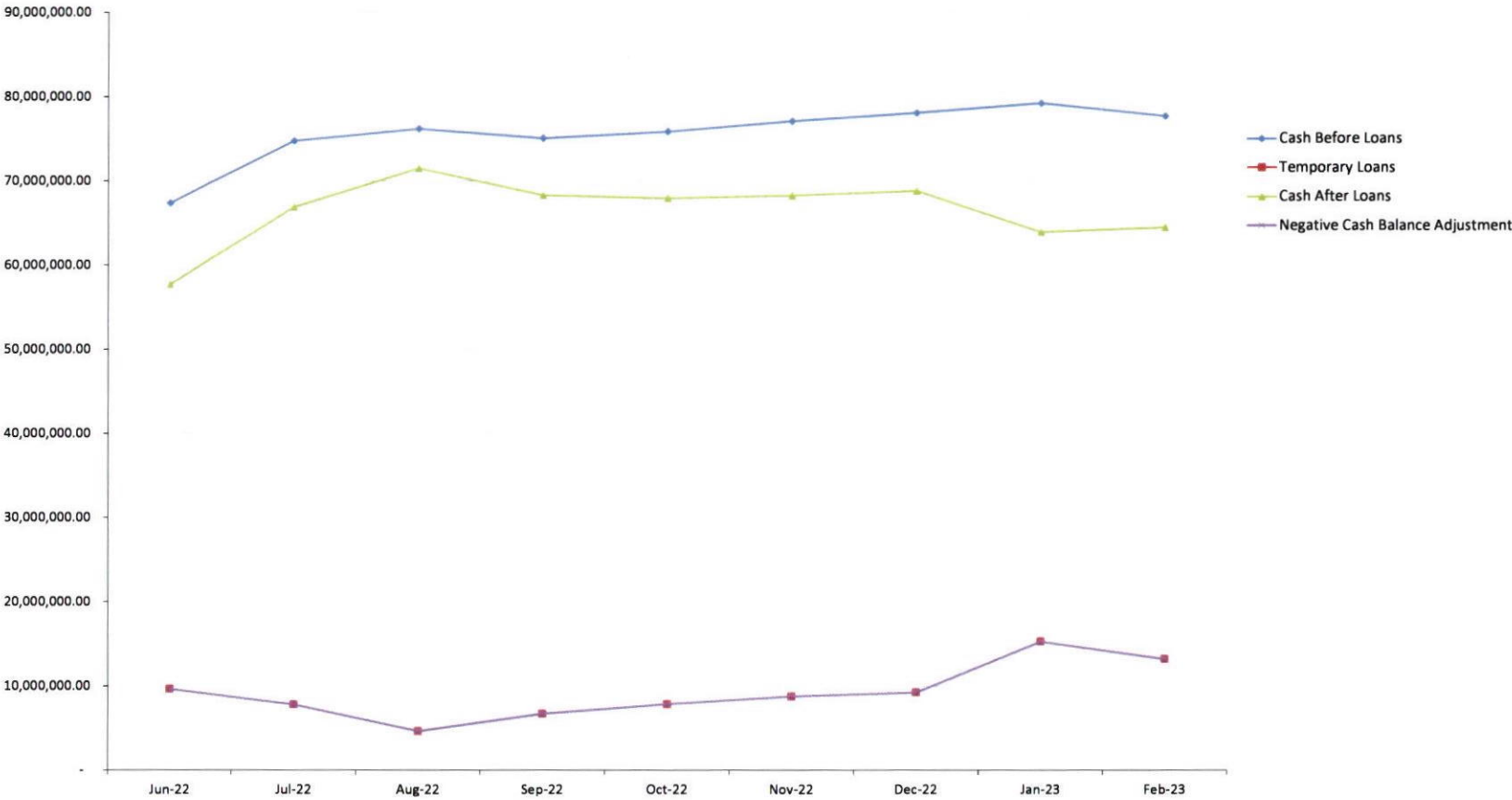
GISD 2022-23 EXPENDITURES BY FUND FEBRUARY 2023



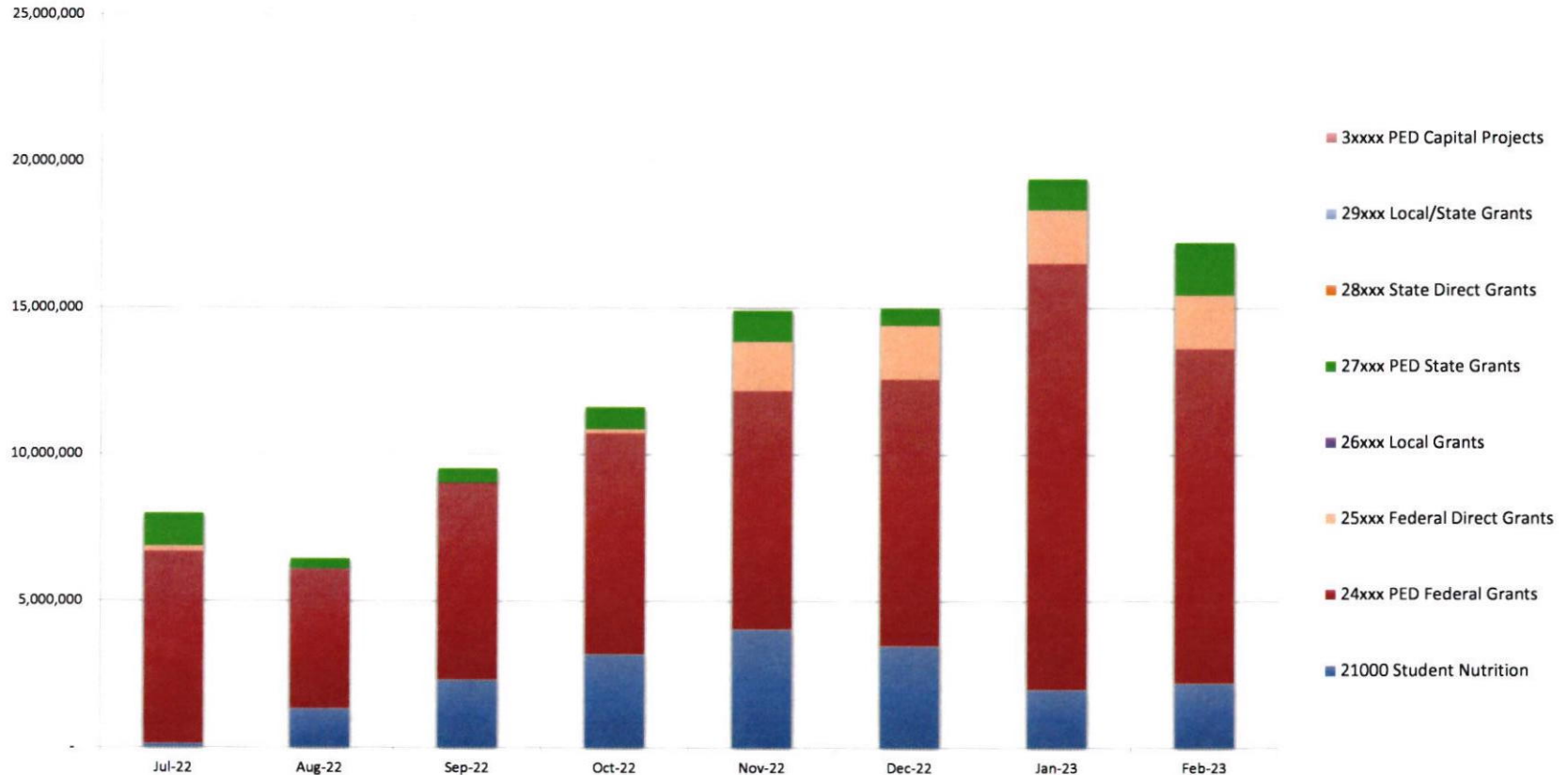
