

REGULAR SCHOOL BOARD MINUTES

For April 6, 2023

1. The Gadsden School Board convened in regular session at 5:05 p.m. President Laura Salazar Flores presided at the meeting held at the Gadsden Administrative Complex.

Introduction And Roll Call

Members present: Daniel Castillo Laura Salazar Flores, and Arlean Murillo.

Claudia Rodriguez was absent.

Mission Statement

- 2. The Pledge of Allegiance and the Pledge to the New Mexico flag were recited. The mission statement was read by Daniel Castillo.
- 3. Superintendent District updates and recognitions:
 - A. Superintendent Dempsey introduced the Santa Teresa Charitable Foundation. The STCF presented an \$18,000 check to the participating schools in the Honors Program: Desert View Elementary, Riverside Elementary, Sunland Park Elementary, Yucca Heights Elementary, Chaparral Elementary, and La Union Elementary.
 - B. Principal Legarreta from Gadsden High School recognized Elmer Montoya as the 2023 Daniel's Fund Scholarship Program Recipient. The Daniel's Scholarship Program provides the opportunity for motivated students to attend any two- or fouryear accredited college or university. Daniels Scholar will receive up to \$100,000 and is dependent upon degree plan and expected family contribution. It is renewable up to four academic years. Only 238 students selected from New Mexico, Colorado, Utah and Wyoming. Elmer Montoya is planning to graduate with a double major in Finance and Business Management and has a GPA of 4.1.

Number of Discussion C. President Flores presented information on the Number of Items on Board Discussion Items on Board Agenda. The agenda is a Agenda development process that is addressed in the policy. There are currently no limit to the number of discussion items. The length of board meetings is impacted by the number of items included on the agenda. The efficiency of board meetings is also determined by the leadership team providing the necessary information 72 hours prior to the meeting and the time spent by board members reviewing the information. Leadership team members are always available to provide additional information outside of the board meetings. Project Search Update D. Mr. Rapanut, Director for Special Education, presented information on the Project Search Update. He stated that the Project Search Steering Committee has met with upper level management, the Director of the Board, and Human Resources personnel from La Clinica de Familia three times. La Clinica de Familia would like to be a host site and is completing all the paperwork to get approval from Project Search. The proposed work location is the La Clinica de Familia Behavioral, Dental, and Medical Clinic that are located together in Anthony. There are currently eight students who be in their final year of eligibility and ready to begin the Project Search program in SY 2023-2024. During staffing on March 30, 2023, the Special Education Department requested funding from the operational budget for a Special Education Teacher FTE and a Special Education Instructional Assistant FTE to reestablish Project Search in GISD for SY 23-24. Redesign of the E. Superintendent Dempsey presented information on the Redesign Superintendent's of the Superintendent's Evaluation Tool. He further explained **Evaluation Tool** that the working committee was established by Mr. Castillo and Board Secretary Murillo. We contracted with Cooperative Educational Services to help develop a evaluation tool that also tied to the GISD Strategic Plan. A draft copy was presented to the working committee on Monday, March 20, 2023 and suggestions were made to ensure the tool was aligned with policy and a common language was evident throughout the document. It was suggested to have a Special Board Meeting on Thursday, April 27, 2023 at 4:00 pm at the Gadsden Administrative Complex to review the Superintendent's **Evaluation Tool.** Student Dress Code F. Superintendent Dempsey recommended approval of the motion. A roll call vote was taken, Armando Cano, Daniel Castillo, Laura Salazar Flores, and Arlean Murillo all voted "aye". Motion carried unanimously. The Board went into Closed Session at 6:35 p.m.
Reconvene	13. Mr. Castillo made a motion to reconvene in open session. President Flores made a motion that the Board increase Superintendent Travis L. Dempsey salary by \$5,000 and that his salary be included in the standard raise that applies to all other district employees. In addition, President Flores made a motion that the contract be extended an additional 2 years to expire June 30, 2026, and to include a district vehicle, no changes in leave, no changes in insurance or increase in reimbursement for travel except actuals on out-of-state travel with board members. Motion carried unanimously. The Board reconvened in Open Session at 9:00 p.m.
