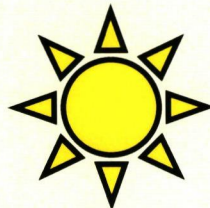

April 30, 2024

1. Operational Fund Revenues as of April 30, 2024 - \$133,868,341 which represents 83.73% of budgeted Revenues.

2. Operational Fund Expenditures as of April 30, 2024 - \$125,583,646 which represents 55.50% of budgeted Expenditures.

3. The April 30, 2024 Operational Fund Cash Balance before loans was \$74,696,847. The cash balance after temporary loans of \$4,979,222 to the grant funds was \$69,717,625. Grant funds that reported a negative cash balance as of April 30, 2024 totaled \$4,979,222 which represents a decrease of \$510,458 from the March 31, 2024 negative balances.

4. As of April 30, 2024, the PED and other grant funding agencies owed the District approximately \$5,549,532 for current year Grant Fund expenditures, \$0 for Capital Projects, and \$2,101,529 for Student Nutrition. These amounts are not reflected in the temporary loans noted in Item 3 above. The negative cash balances noted in Item 3 are a result of the outstanding amounts owed to the District. (See Exhibit A Outstanding Reimbursements)

5. Total Revenues for all funds as of April 30, 2024- \$262,666,235. Of the total revenues received, the Operational Fund accounted for 50.97%, the Grant Funds 24.08%, Building Funds 13.19%, Debt Service Funds 4.85%, Student Nutrition 3.75%, and all the other funds 3.16%.

6. Total Expenditures for all funds as of April 30, 2024- \$214,443,610. Of the total expenditures incurred, the Operational Fund accounted for 58.56%, the Grant Funds 19.16%, Building Funds 6.99%, Debt Service 7.73%, Student Nutrition 4.77%, and all other funds 2.79%.

7. Direct Instruction expenditures plus encumbrances for the Operational Fund as of April 30, 2024 were \$100,724,857 or 62.62% of the total Operational Fund expenditures.

8. Pledged collateral – All bank accounts in compliance requirement as of April 30, 2024. See separate report attached Item III Summary of Investments.

9. For the month of April 2024, one school and two departments were randomly selected for review. The review focused on deposit activity and purchasing transactions. For each of the schools/departments selected, deposit activity for the month was reviewed for timeliness of deposit. Purchase orders for the schools and/or departments were reviewed for "after-the-fact POs". Procurement card purchases were reviewed for compliance with District procedures.

- Operational Fund Revenues as of March 31, 2024 - \$120,905,733 which represents 75.62% of budgeted Revenues.
- Operational Fund Expenditures as of March 31, 2024 - \$110,862,098 which represents 48.99% of budgeted Expenditures.
- Total Revenues for all funds as of March 31, 2024- \$239,434,951. Of the total revenues received, the Operational Fund accounted for 50.50%, the Grant Funds 23.22%, Building Funds 14.38%, Debt Service Funds 5.13%, Student Nutrition 3.61%, and all the other funds 3.16%.
- Total Expenditures for all funds as of March 31, 2024- \$190,080,822. Of the total expenditures incurred, the Operational Fund accounted for 58.32%, the Grant Funds 18.40%, Building Funds 7.05%, Debt Service 8.71%, Student Nutrition 4.82%, and all other funds 2.70%.
- Direct Instruction expenditures plus encumbrances for the Operational Fund as of March 31, 2024 were \$100,064,313 or 62.74% of the total Operational Fund expenditures.

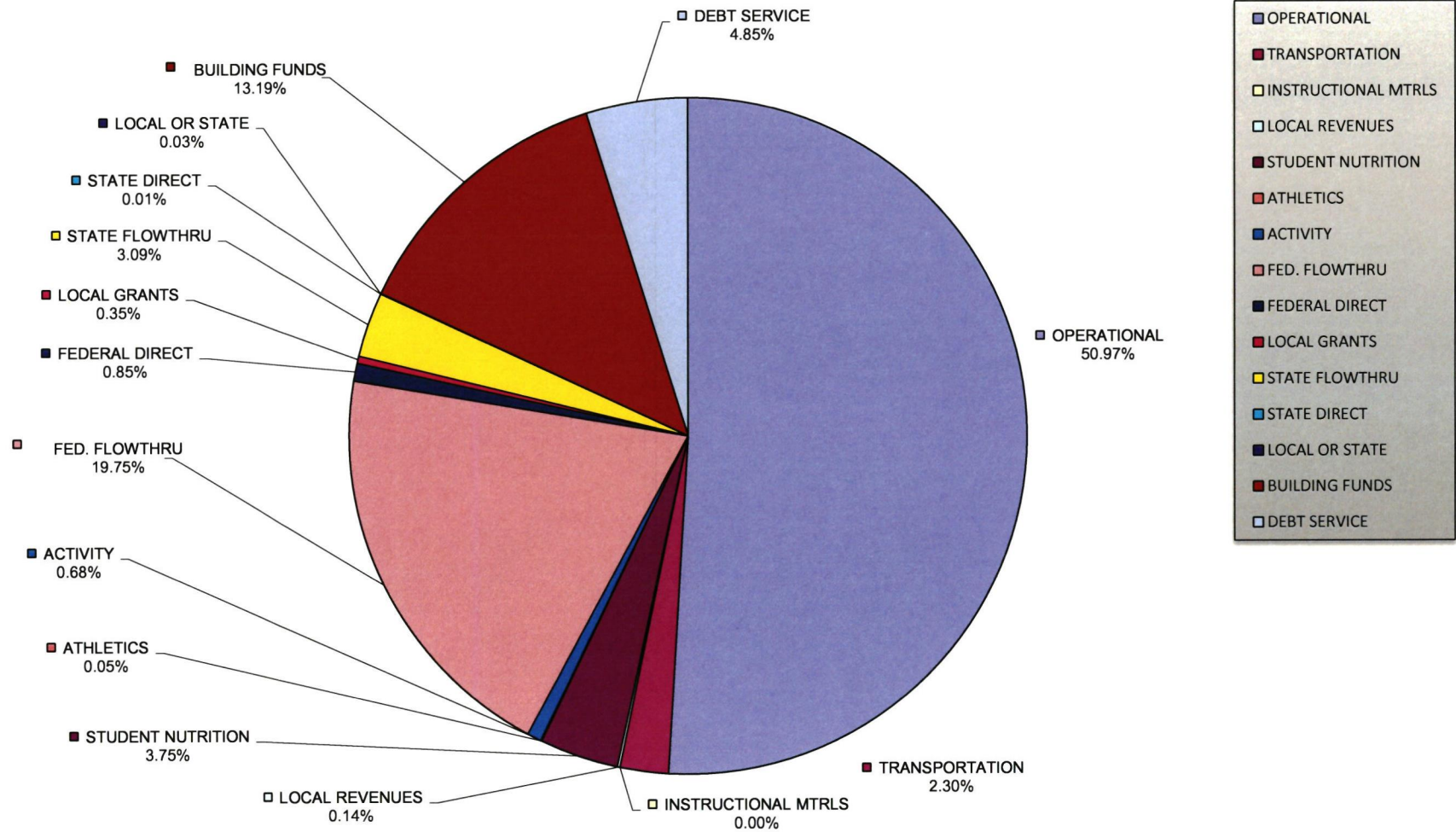

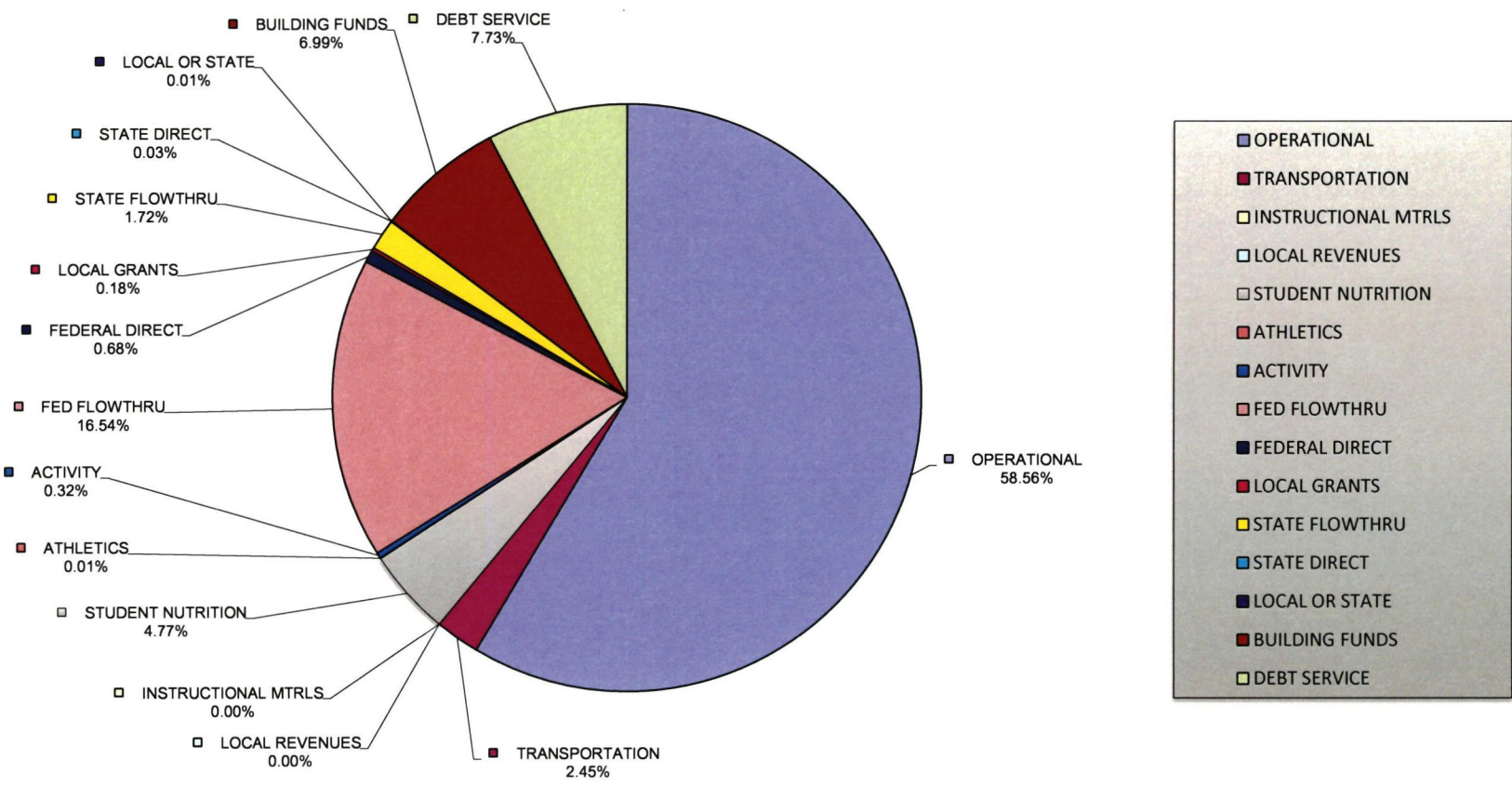

GISD 2023-24 REVENUES BY FUND APRIL 2024

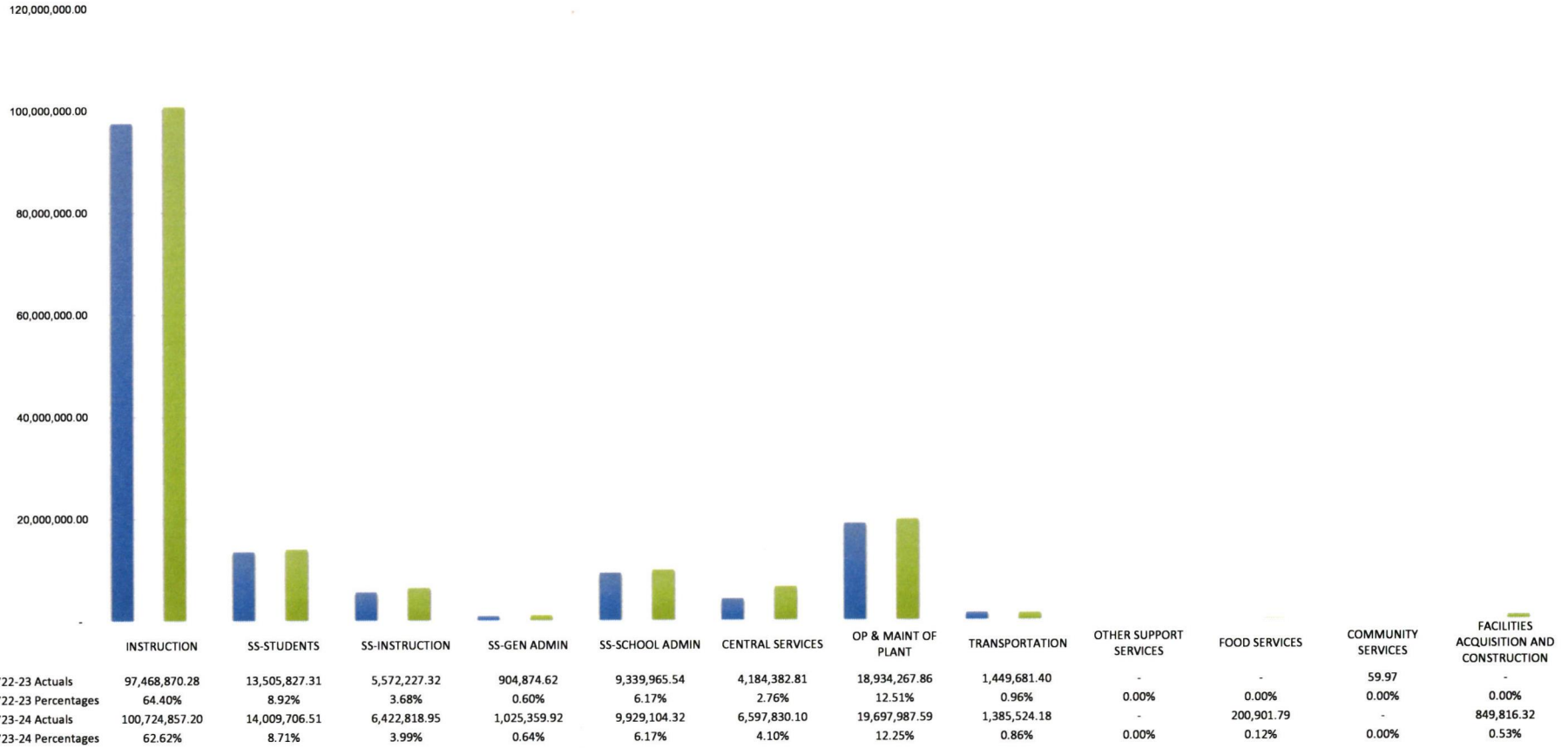


GISD 2023-24 EXPENDITURES BY FUND APRIL 2024

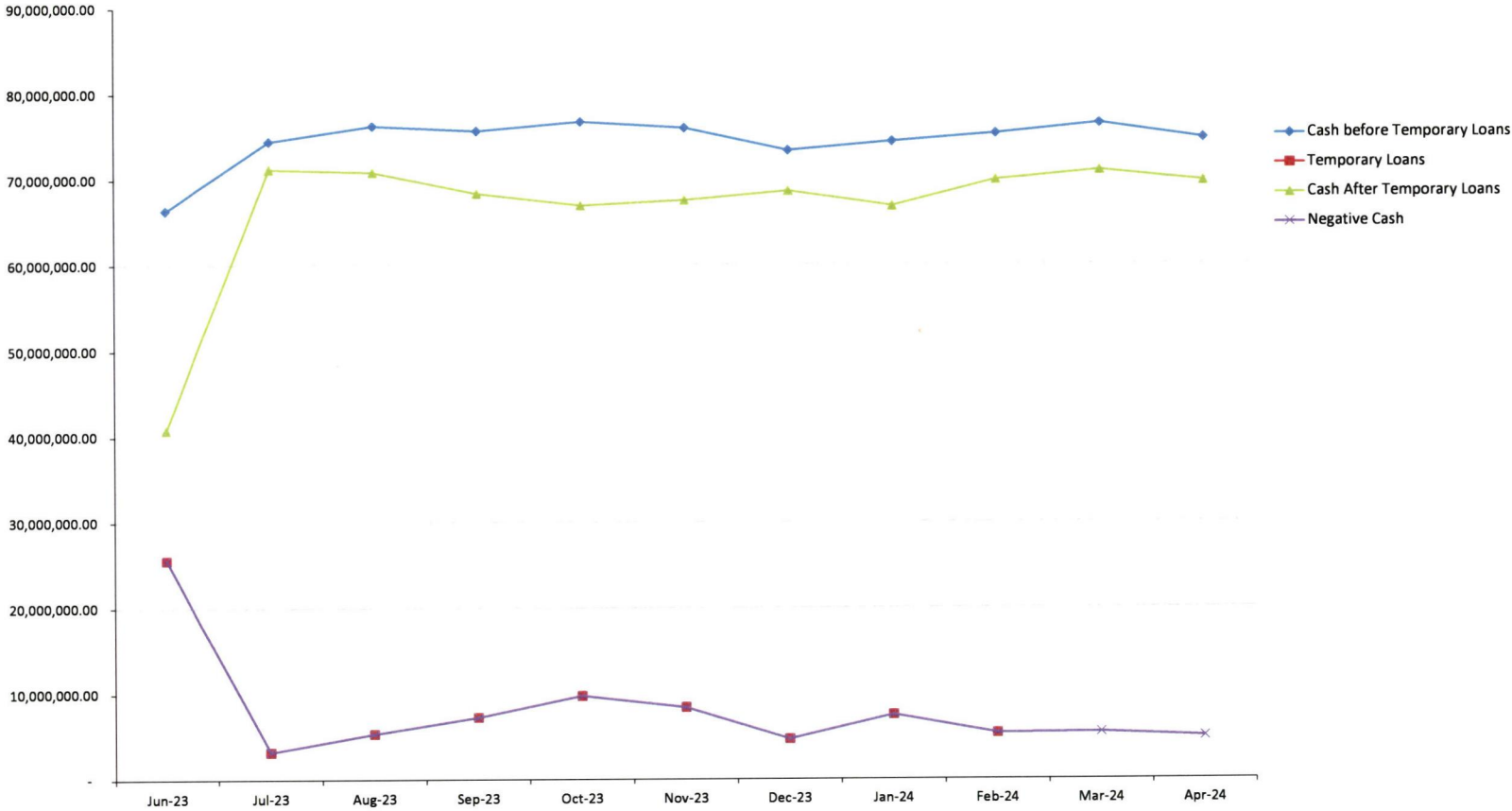


OPERATIONAL FUND EXPENDITURES AND ENCUMBRANCES FOR APRIL 2024 COMPARED TO APRIL 2023

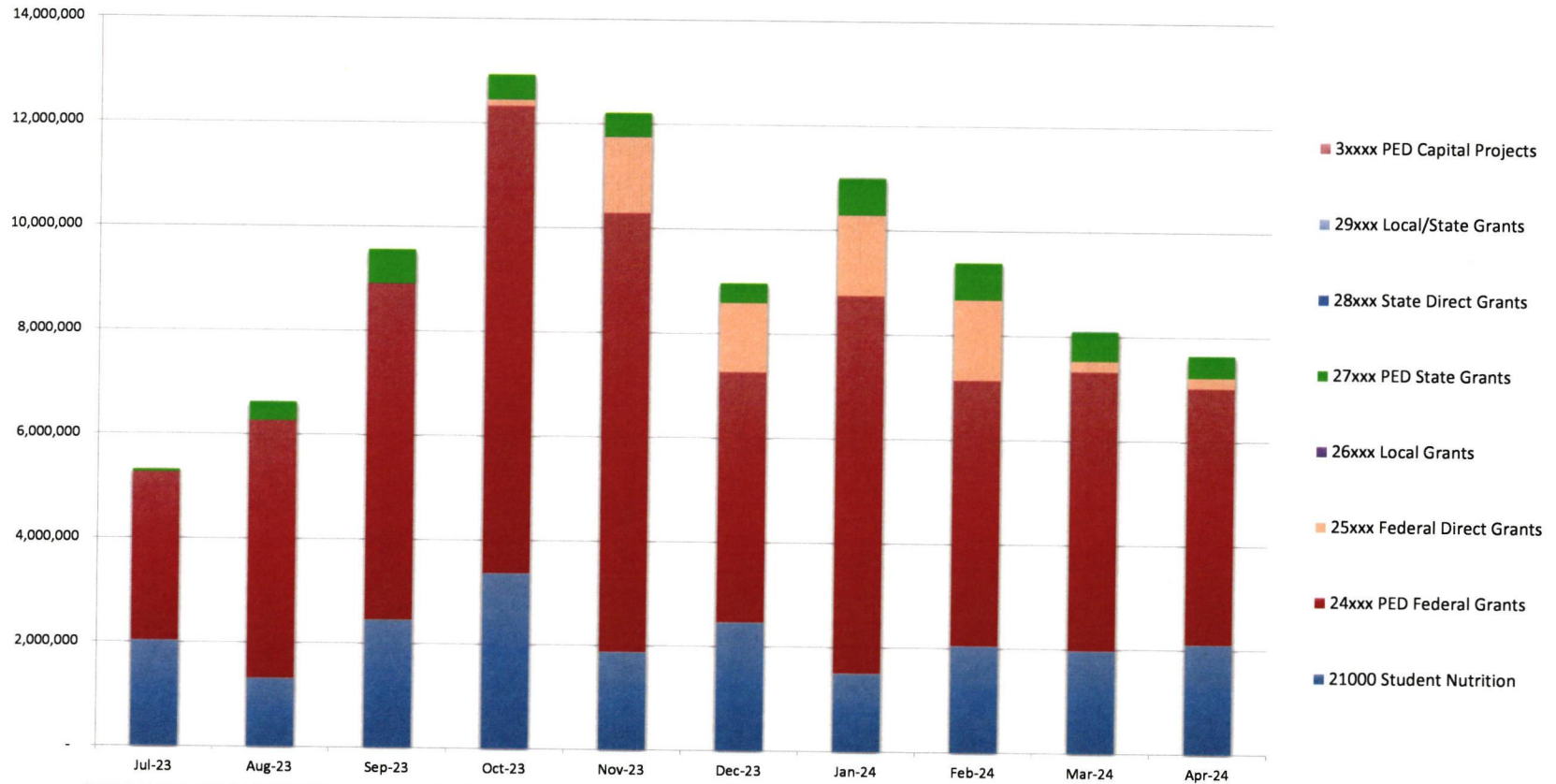
